

This document defines the terms of agreement between the developers of Mc-Sym (hereafter referred to as the LICENSOR) and you, the end user (either an individual or an entity hereafter referred to as the LICENSEE) concerning the distribution and the use of the Mc-Sym computer package (hereafter referred to as the SOFTWARE) for three-dimensional modeling of RNA. The LICENSOR grants the LICENSEE a nonexclusive license to use the SOFTWARE in accordance to the following terms:

TERMS

- 1. A nontransferable license is granted to the LICENSEE to install and use this SOFTWARE on a workstation located at the LICENSEE's institution. Use of the SOFTWARE is restricted to the LICENSEE and collaborators at his/her institution who have agreed to accept the terms of this license. The LICENSEE may not make copies of the SOFTWARE, except for backup purposes.
- 2. The LICENSOR retains ownership of all materials (including SOFTWARE and documentation) delivered to the LICENSEE. No modifications or derivative works based on the SOFTWARE are permitted.
- The LICENSEE shall not disclose in any form the delivered SOFTWARE to third parties without prior written authorization from the LICENSOR.
- 4. Documented written requests from the LICENSEE for additional code on which the delivered SOFTWARE is based can be made to the LICENSOR; such code will be subject to and controlled by the terms of this license; any such request will be honored at the discretion of the LICENSOR.
- 5. THE LICENSEE AGREES THAT THE SOFTWARE IS SUPPLIED ON AN AS IS BASIS AND THAT THE LICENSOR IN NO WAY WARRANTS THE SOFTWARE OR ANY OF ITS RESULTS AND IS IN NO WAY LIABLE FOR ANY USE THE LICENSEE MAKES OF THE SOFTWARE.
- 6. The LICENSEE agrees that any reports or publication of results obtained with the SOFTWARE will acknowledge its use by an appropriate citation. Until further notice this would refer to the SOFTWARE as obtained from the LICENSOR. One copy of each publication will be supplied to the LICENSOR
- 7. When a signed License Agreement and a check or money order (made to the Université de Montréal / Mc-Sym) have been received, an encrypted key to unlock the SOFTWARE will promptly be sent to the LICENSEE.
